Work Details: The engineer attended the site and found the shutter pulled through the stop and secured with a bag. The curtain was repositioned back into the guides, unbagged, and lowered. During the process, damaged laths were discovered on the right-hand side, along with the bottom lath and bottom bar being shorter than the rest of the curtain and only 5-10mm in the guide. Additionally, there was excessive movement in the right-hand guide. It is recommended to replace the damaged parts and re-fix the right-hand guide. The operation was left in place, but caution is advised until the necessary repairs are completed.	£365.00
