During inspection and testing, it was found that the barriers operate correctly when not paired but fail to function when connected as master and slave—there is no closure, the waiting-for-passage report is acknowledged, and the traffic light does not switch in this mode. After speaking with Daniel on-site, it was confirmed that the technician who made the changes used a laptop and will return next week, possibly to resolve the issue.
