The curtain has been repositioned into the guide, and the supply cable was traced to the building's entry point. Access to the building was gained with tenant authorization to locate a locked electrical cupboard. The GID office was informed, and they arranged for the client to bring the key for access. Vic Starks attended the site. Attempts to reset the RCD resulted in it tripping repeatedly. The panel was removed from the supply and reset again, but it continued to trip. Vic contacted the electricians who replaced the panel in October, and it was agreed that a fault must have developed on their end.	£471.25
